## 4. First-Aid Measures

**INHALATION:** Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

**EYE CONTACT:** Rinse immediately with plenty of water for at least 15 minutes. Contact a doctor if symptoms persist.

## 5. Fire Fighting Measures

## **7. Handling & Storage**

**PRECAUTIONS IN HANDLING:** Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene. Do not eat, drink or smoke whilst handling.

Acute oral rat LD50 3.4ml/kg. (D.L. J. Opdyke *FCT* 1975, **14**). Skin sensitizer. Effects reduced when applied to skin in combination with eugenol and d-limonene. IFRA recommends that cinnamon oil should not be used as a fragrance ingredient at a level of over 0.2% in the final product, due to its sensitising potential.
