4. First-Aid Measures

INHALATION: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

5. Fire Fighting Measures

EXTINGUISHING MEDIA: Use CO₂, Dry Powder or Foam type Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

CLEAN UP METHODS FOR SPILLAGES: Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe municipal, federal and local disposal regulations.

PRECAUTIONS IN HANDLING:	Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene. Do not eat, drink or smoke whilst handling.
