**DEFINITION/BOTANICAL ORIGIN:** The volatile oil obtained by steam distillation of the freshly cut flowering tops of the herb *Lavandula angustifolia* P. Miller (Fam. *Labitae*)

## 3. Hazards Identification

Concentrated product. Do not ingest, use good housekeeping procedures when handling.

## 4. First-Aid Measures

**INHALATION:** Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.  
**EYE CONTACT:** Rinse immediately with plenty of water for at least 15 minutes. Contact a doctor if symptoms persist.  
**SKIN CONTACT:** Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, seek medical advice.  
**INGESTION:** Rinse out mouth with water. Seek medical advice **immediately**.  
**OTHER:** When assessing action take Risk & Safety Phrases into account (Section 15).

## 5. Fire Fighting Measures

**EXTINGUISHING MEDIA:** Use CO<sup>2</sup>, Dry Powder or Foam type Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.  
**SPECIAL MEASURES:** Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.  
**EXTINGUISHING PROCEDURES:** Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

## 6. Accidental Release Measures

**PERSONAL PRECAUTIONS:** Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.  
**ENVIRONMENT PRECAUTIONS:** Keep away from drains, soils, surface & ground waters.  
**CLEAN UP METHODS FOR SPILLAGES:** Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe municipal, federal and local disposal regulations.

## 7. Handling & Storage

<b>PRECAUTIONS IN HANDLING:</b>	Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene. Do not eat, drink or smoke whilst handling.
<b>STORAGE CONDITIONS:</b>	Store in tightly closed original container, in a cool, dry & ventilated area away from heat sources & protected from light. Keep air contact to a minimum.
<b>FIRE PROTECTION:</b>	Keep away from ignition sources & naked flames. Take precautions to avoid static discharges in working area.

<b>RESPIRATORY PROTECTION:</b>	Avoid breathing product vapour. Apply local ventilation where possible.
<b>VENTILATION:</b>	Ensure good ventilation of working area.

<b>EYE PROTECTION:</b>	Use safety glasses.

Acute oral LD50: >5g/kg, Dermal LD50: >5g/kg. opdyke D.L.J. (1976) *Food Cosmetics & Toxicology* **14**, 453, *ibid FCT* **14**, 449 found lavender oil non-sensitising and non-irritating to skin with no potential human phototoxic effects. More recent work indicates that lavender oil may have some CNS depressant activity (see S. Atanasova Shopova et al. (1974) through *Chem Abstr.*, **81**, 58356j.)
