## 2. Composition / Information on Ingredients

**DEFINITION/BOTANICAL ORIGIN:** Rose Geranium oil is obtained by the steam distillation of the flowering herb *Pelargonium graveolens* l'heritier ex Aiton, p.roseum willdenow and other non-defined hybrids, strains selected for rosaceous odour.

## 3. Hazards Identification

Concentrated product. Do not ingest, use good housekeeping procedures when handling.

## 4. First-Aid Measures

**INHALATION:** Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

## 5. Fire Fighting Measures
